Witness’ inadvertent encounter in a courthouse elevator with some of the jurors and communication with victims did not require a mistrial. Evidence did not support a voluntary intoxication instruction. Trial court did not err by allowing the use of a 2004 felony marijuana-trafficking conviction in the PFO portion of the case.
